All members will need to adhere to Public Health guidelines including:

- Any club/skating school members who themselves have travelled outside of Canada, or has someone in their household who has travelled outside Canada must self-isolate and not participate in club/skating school activities for 14 days, unless the individual has a Government of Canada Travel Exemption
- Any individual who has been exposed to someone with a confirmed case of COVID-19 should self-isolate and is not permitted to participate in club/skating school activities for 14 days, unless they engaged in consistent and appropriate use of PPE (i.e. healthcare workers)
- Any individual with symptoms of COVID-19 is not permitted to take part in club or skating school activities
- Any individual who has someone in their household showing symptoms of COVID-19, should not participate in club/skating school activities

Parent(s)/Guardians need to immediately contact a member of the COVID-19 Oversight Group if any of the above apply.

Additional requirements of Parents/Guardians:

- Pre-screening of your skater(s) prior to coming to the arena.
- All parents will be required to help with verbal screening and sanitization of designated dressing rooms/areas at the arena. A list with assigned duties and dates will be provided once registration is complete. If any parent/guardian is unable to do their assigned date they must find another parent/guardian assigned to that room/area to replace them.

The DDFSC Board would like to thank everyone for their cooperation, patience and understanding as we safely navigate our return to skating.
